**Application:** Please read all instructions and rules carefully and fill out requested the information completely. Applications must be received by **Wednesday, July 14, 2010**.

**Fees:** Enclose a check or money order made payable to the Baltimore County Corvette Club for the **\$25** (all vendors). **If accepted for the event, this is a non-refundable reservation and processing fees.** Nonprofit organizations pay \$20.00 (proof of non-profit status required).

**Notification:** Decisions of the **Baltimore County Corvette Club** are final. All vendors must send a check or money order for your vendor space(s) by Wednesday, July 14, 2010. Failure to meet this deadline will require vendor to pay the day of show price. ***Sorry, no exceptions will be made.***

**Vendor Spaces:** Each space will be approximately 15'x15' in an open, grassy area of the park. Double spaces will be approximately 30'x 15'. Three sided or frontal only displays are encouraged. Coordinators will be onsite on the event date to assign sites. If you **MUST** have your vehicle next to your display you will be required to pay for 2 sites minimum. There is parking for the vendors fairly close by, next to shelter

**Set-up Times and Procedures:** Event date is **Saturday, July 17, 2010, 10am-3pm**. Set up time is **9am for vendors and exhibitors**. Vendors are asked to remain onsite for the duration of the event.

**Taxes:** Each vendor is responsible for applicable tax.

**No Refunds:** An application is a commitment to show when accepted by the Show Coordinators. No refunds (of security deposit or vendor fee) will be made for cancellation after notification of acceptance or for removal from the festival.

**Manning of Vendor Space:** All vendors must be prepared with sufficient inventory to display for the duration of the show. Vendors are required to preside over their spaces.

**Perryville Outlets and Baltimore County Corvette Club reserve the following rights:** 1. To review all displays throughout the event to ensure that all rules are being followed; 2. To not be responsible for any loss, theft, or damage; 3. To refuse any product considered unsuitable or inappropriate; 4. To change space assignments if deemed necessary.
